



**ORDER NO. 7
GRANTING UNOPPOSED MOTION TO SET HEARING IN BASTROP, TEXAS**

On December 4, 2013, the General Manager of Lost Pines Groundwater Conservation District (District) filed an Unopposed Motion to Set Hearings in Bastrop, Texas (Motion). The District's contract with the State Office of Administrative Hearings specifies that the hearing will be held in Bastrop, Texas. Accordingly, the Administrative Law Judge (ALJ) grants the Motion. The January 10, 2014 hearing on pending motions will be held telephonically. If a hearing on pending motions is necessary, the ALJ will contact the parties and hear oral argument. Typically, for pending motions, the ALJ can rule from the written pleadings without the necessity of oral argument. With regard to the hearing on the merits, the first three days of the February 11-14, 2014 hearing on the merits will begin at 9:00 a.m. and be held at the Bastrop Convention and Exhibit Center, 1408 Chestnut Street, Bastrop, Texas 78602. The fourth day of the February 11-14, 2014 hearing on the merits will begin at 9:00 a.m. and be held at Bastrop City Hall, 1311 Chestnut Street, Bastrop, Texas 78602.
